We hereby specify that, as part of the services provided, your data will be processed lawfully, correctly and transparently, ensuring that they are accurate and appropriate, relevant and limited to what is necessary with regard to the purposes from time to time pursued of the service accessed. Without prejudice to this, the art. 13 of the Regulation states that when the Data Controller collects data from the data subject, he must provide a series of information that we represent below.

### **LEGAL BASIS OF TREATMENT AND PURPOSE**

Your data will be processed for the institutional purposes of the tour operator, indicated in detail in this information regarding assistance and information services with telephone and chat, email to the various email addresses listed in the web site) on the services provided by Gigatour or partner, involve the acquisition of contact data of the sender, necessary to respond, as well as all personal data included in communications.

### **COOKIES AND OTHER TRACING SYSTEMS**

We do not use cookies for user profiling, nor are other tracking methods used. (See the Policy Cookies)

Instead, session cookies (non-persistent) are used strictly limited to what is necessary for the safe and efficient browsing of the sites. The storage of session cookies in the terminals or browsers is under the control of the user, where on the servers, at the end of the HTTP sessions, information about cookies remains recorded in the service logs, with storage times no longer than seven days like other browsing data.

### **DATA RECIPIENT**

Personal data will be processed exclusively by Gigatour personnel and collaborators and by companies expressly appointed as Data Processors. Apart from these cases, the data will not be disclosed to third parties or disseminated, except in cases specifically provided for by national or European Union law.

### **DURATION OF TREATMENT**

The Data Controller will process personal data for the time necessary to fulfill the above purposes and in any case no later than 24 months from the date of consent to the processing, consent that may be revoked at any time without prejudice to the lawfulness of the processing performed before the revocation itself.

## **RIGHTS OF THE INTERESTED**

We also inform you that for each service requested you will be able to ask the Data Controller to access your personal data (Article 15), the correction (Article 16) or the cancellation (Article 17) of the themselves, the limitation of the processing that concerns them (Article 18) or to oppose their treatment (Article 21), in addition to the right to data portability (Article 20).
